

A New Day for Local 30

Marianne Giordano has been president of Local 30 working together with Walter Allen, Executive Director and Chief Financial Officer for the past seventeen years. Since his arrival at Local 30 in 2001 first as International Union Trustee and then elected by the members as Executive Director/CFO, Allen has trained and mentored those around him to ensure a secure future for the union, and certainly no one more than Giordano. Together they have brought much success to Local 30 and its members and created an organization that is broadly respected both inside the union and out. Now it's time to open the next chapter for Local 30 as Allen retires from his position as Executive Director/CFO.

"As I step back from my full-time responsibilities and Marianne assumes the position of Executive Director/CFO I am confident in her ability and her commitment to this great union," reported Allen. "She is certainly ready for the challenges ahead and has the skill and passion that will make her successful. Marianne has been a large part of the progress of our union for many years leading much of the work that got us here. She is more than ready to take us to the next level."

Allen first announced his retirement from full-time service in October of last year citing a number of changes to the OPEIU Staff Pension Plan that took place on January 1, 2019, and which will negatively impact the benefits he has earned over a nearly thirty-five-year career. While he will step down from his elected position with Local 30 he will continue in a part-time advisor roll for the foreseeable future working with Giordano to ensure a smooth transition.

The Executive Board of Local 30 has accepted Allen's retirement and has elected Giordano to replace him as Executive Director/Chief Financial Officer by a unanimous vote. "Walter has done an amazing job leading our union, no one can replace Walter," stated Giordano. "Like all Local 30 members I deeply appreciate all Walter has done for us and for our union and I pledge to continue the work we have done together and continue our success."

In addition to Allen, Vice President Cathy Young and Board Member Carmen Corral have both decided to step down from their elected positions as well. Both are retirees from Kaiser Permanente and are active with the Local 30 Retirees Committee and plan to continue that work for the union. ACI Reaches New Contract

The professional supervisors represented by Local 30 at Alternate Concepts, Inc (ACI) in Phoenix, Arizona has ratified their new collective bargaining agreement. ACI runs the light rail in Phoenix and our supervisors are responsible for the safe and efficient management of the system.

Following a long and protracted bargaining process that included multiple attempts to reach an agreement the members could ratify; the committee finally won that agreement. The pact covers annual wage increases as well as an upfront bonus and other payouts, as well as benefit improvements that were sought by the members.

The bargaining committee members were stewards Rudy Fimbres, Shannon Tate, and Tangie Burleson.

"This was a difficult process which needed the constant attention of the committee," reported Executive Director Walter Allen who helped the group reach the agreement. "I have worked with many committees in my time and these leaders were the most patient and determined I have ever seen. It was because of their hard work that this got done."



"We certainly had our challenges," said Tangie Burleson. "This one took a lot of time and a lot of work, but we did make some important improvements and took steps in the right direction."

"This was a tough one for sure," stated Shannon Tate. "You never get everything you ask for in bargaining, but you do have a bottom line and the goal is always to do the best you can for your members. I believe we did just that. We will be ready to go again in a couple of years to finish what we started."

Our work to secure the National Agreement we want goes on, and the need to be united and strong is critical. Your Local 30 leaders are committed and will continue for as long as it takes.
