And, our members at Sodexo working at Sharp **Grossmont Hospital also will** begin bargaining later this year. These workers provide contracted services for EVS and Food and Nutrition services. Working for a private, for-profit contractor to the Sharp Hospital System is a challenge as these workers receive pay and benefits well below the market average in their region. SODEXO EMPLOYEES FIGHT ON

Local 30 members employed by Sodexo, Inc. working at Sharp Memorial and Mary Birch Hospitals, and Sharp Chula Vista Hospital have each been in bargaining for several months and continue to work toward a fair settlement. These workers provide environmental and food services to these Sharp hospitals under a contract with Sodexo.

Local 30 members at Memorial and Mary Birch are negotiating a renewal to their contract attempting to achieve wage increases and some benefit and language improvements. Much of the language has been completed and the wages and benefits remain in discussion. The bargaining committee remains firm in their positions and expects a settlement in February.

At the Chula Vista bargaining table, the parties are working on a first contract as this group only recently organized with Local 30. While most of the language of the new agreement is now complete the economic issues are not quite finished. Wages and some benefits remain unresolved. This committee also believes a settlement is within reach and members should be voting on a contract in the coming weeks.

"We are getting very close with both of these units and fully expect to present packages to these members for ratification within the next few weeks," reported Annette Baxter, Local 30 Director of Member Services and lead negotiator for both units. "Our teams are in this to win." ★

In each of our regions these contributions go to the Labor organization that provides for those less fortunate, and as always Local 30 leads the way in these areas. We are always proud to show our support for the good works of our Labor affiliates.

Finally, we continue to manage our assets and control our expenses in order to always provide the best representation possible to our members and at the same time keep their costs down. Despite higher than usual expenses in 2019 due in large part to the Kaiser strike planning, our finances remain strong. These are the exact kind of issues we constantly plan and save for, just in case. This strategy has worked well for our Local for many years, never more than in 2019. We will continue to employ this strategy going forward.

2020 looks to be another very busy year and we look forward to working together as always to be the strong and positive force for our members that they deserve.

PSP PAYOUTS TO KP MEMBERS

In late February Local 30 members employed by Kaiser Permanente and the California Service Center received their annual Performance Sharing Program (PSP) bonuses for 2019. And, the amounts earned were among the highest ever paid out for this program. Payouts varied based on which KP entity an employee works for and based on some personal performance as well. Payouts averaged between \$2,800 and \$3,000 per full-time employee (part-time employees are prorated based on hours worked).

The PSP is part of the National Agreement between KP and the Coalition of KP Unions. The Program is based on both the financial performance of the company and our members' performance against goals that are jointly decided in Partnership such as attendance goals, workplace safety measures, and others. 2019 was a very successful year for the company, and our members performed well against their goals which made for the higher than usual payouts.

"All throughout National Bargaining we were constantly reminding the employer that their workers deserved to share in their success," said Marianne Giordano, Local 30 Executive Director. "This is a perfect example of that mindset. We bargain these agreements to ensure that all employees have a chance to share in the wealth through higher than market wages, better benefits, and yes, bonus payouts every year. Our members did very well this year and are already off to a good start for 2020 as well."
