First off, Kaiser Permanente San Diego has just opened a brand-new hospital, their first in many years in San Diego. The new San Diego Medical Center (SDMC) is remarkable in many ways starting with the fact that it is the most technologically advanced hospital

Local 30 and Sodexo Settle New Contract

Sodexo workers represented by Local 30 have settled their new three-year agreement with wage increases, retroactive pay, and benefit improvements. These Local 30 members are employed by Sodexo Corporation, the subcontractor that provides food services and environmental services at Memorial and Mary Birch Hospitals in San Diego.

Tracy Brown, Jasmine Crump, Miguel Chavez and Lorenzo Diaz made up the Local 30 Bargaining Committee assisted by Business

Agents Mark Bailey and Angela Jensen, and Walter Allen, Executive Director.

The company and the union had been in bargaining since last August. The discussions dealt with many long-term issues and were at times interrupted by other issues at the hospitals during those months as the Sharp system that owns the hospitals fought with their nurses over similar issues. The committee members worked hard to bring back the settlement and never gave up. The

ever built. This facility, and the new medical office building being built right down the street will be the new workplaces for many Local 30 members as some of the departments moved from the Zion Medical Center starting back in April. Zion will remain open however providing certain services not moving to SDMC. This is good news for KP patients and for our members. These new facilities represent growth for KP and for Local 30.

While we are talking about Kaiser, I am happy to report that Local 30 members there recently received their Performance Sharing Program (PSP) bonuses for their work in 2016. This annual bonus payout is the result of performance against certain goals that are jointly decided between management and the unions each year. Then, based upon the financial performance of the company against its margin goals and our performance against our goals such as workplace safety, attendance, service and quality, each member then receives a payout of up to 3% of the total payroll for all positions. While payouts vary from year to year our members have always received at least several hundred dollars in extra pay each year from this program. Congratulations to our members for their efforts once again, enjoy your bonus!

You will read elsewhere in this edition of the newsletter about the events that we have had and the many members and their families who join us. And you will also read about some of the new, exciting benefits that our union offers to all our members. There are many great benefits that we offer to our members, benefits that will save your family a great deal of money. I would like to call your attention to our scholarship programs. In this time of such high college costs families are forced to struggle to pay for their children's education, or in some cases their own. And, when they do finish school most of our members and their kids are strapped with huge student loan debt which they must pay once they are working. While our scholarship programs will not solve the problem completely they can be a big help. Every member of Local 30 is entitled to apply for these scholarships. I urge you to apply for yourself, your family members, or both every year. You cannot win if you do not enter.

package was ratified unanimously by the members and took effect retroactively to September 1, 2016.

“This was the longest negotiations we have had with this employer to date,” reported Business Agent Mark Bailey. “The committee members really hung in there and their patience paid off.”

Said one member after voting on the contract, “since we have been with you guys (Local 30) we have not lost anything.”

Another member said “I am very happy to see a wage increase for me because I have been stuck at the top.”

The new contract runs from September 1, 2016 through August 31, 2019. ■

incredible offer right away and start to get out from under.

Many of our members who work for smaller employers may have retirement benefits through defined contribution plans such as 401(k) plans or may not have access to a plan at all. And some of the smaller 401(k)s can have very high fees that come from the employees’ assets in the plans diminishing some of the money they save over their careers. Finally, we have an answer for that problem as well. Starting this July OPEIU will make available a brand new defined contribution plan starting with a 401(k) and 403(b) that will be available to members under a Local 30 contract. These new plans will have many of the latest options and will have the lowest fees possible. Watch the website for more information as we get closer to July.

Lastly, we continue to broaden and strengthen our union’s communications plan. This newsletter is a very part of that plan. Available by first class mail to every member’s home and on the website, in it you will find a lot of valuable information about news and events and benefits for all members and their families. But to be the completely informed Local 30 members, never missing a thing you have other options as well. There’s Facebook, Twitter, Instagram, and naturally our website. Updates from Nurses Council Local 30

This year the Nurse’s Council has participated in the Women’s Day March in San Diego, The Planned Parenthood Rally, and the first week of May, Jacqueline Gilbert, Chairperson and Kelly Curtis, Co-Chair will join Local 30 Recording Secretary Cathy Engler and Business Agent Angela Jensen at the OPEIU Nurse’s Council for the “Nurses Take DC” rally for safe staffing. California currently has staffing ratios for RN’s but most states do not. Two new safe staffing bills have been introduced in New York and Ohio. Democratic Senator Michael Skindell from Ohio has proposed SB 324 to the Ohio legislature. This bill mirrors the staffing ratios set in California in 2004.

New York Assemblywoman Aileen Gunther has proposed A01532 titled the Safe Staffing for Quality Care Act. This bill also sets ratios

and addresses the issues of long term care facilities by determining staffing according to a minimum of care hour per resident per day for RNs, LPNs and CNAs. For RNs it would be calculated at 0.75 divided among all shifts 24 hours a day divided amongst all shifts for seven days a week. For LPNs it is 1.3 hours and CNAs are at 2.8 hours.

Local 30’s response is to support our brothers and sisters from around the U.S. as they meet with the legislators to support safe staffing.

Locally, we will have our 3rd Annual Nurse’s Day Event at the Padre game on Sunday, June 4th. We are 400 plus strong here in San Diego and welcome your ideas for future events, discussions, and projects. Please e-mail Angela at angelajensen@opeiulocal30.org. ■
